- 1. Watching the video series:

- 2. As you watch the video series it is helpful to keep a thinking journal where you take notes on things you struggle to understand or things that you want to know more about. Don't be afraid to concept map (http://cmap.ihmc.us/docs/theory-of-concept-maps) in your notes. Concept mapping is good because it shows the relationship between your ideas.
- 3. In your video watching you may have trouble with some of the Australian accents. If there is anything you don't understand please email me and use your journal to think through topics.

- 4. At the end of the Unit you will need to scan and post your journal at the end of the Unit of study. It generally takes about 4 weeks to watch the videos, reflect using your journal, email and make skype contact.
- 5. Dr Long will announce a Zoom concluding webinar to be held on 29 April as a completion session for this unit of study.
